**J U D G M E N T**

Petitioners in these writ petitions are challenging allocation of reserved seats to different wards/divisions of some of the local bodies in the State for the ensuing election. They are either persons interested in electing their

representatives or getting elected as the representatives of the people in the ensuing election. It is alleged in all the writ petitions that the aforesaid wards/divisions were successively reserved for one or other categories in the elections held during 2010 and 2015 and that the said wards/divisions are reserved again for the third time in the ensuing election. According to the petitioners, the aforesaid wards/divisions having been successively reserved for two consecutive elections, the said wards/divisions cannot be reserved in the ensuing election. The petitioners, therefore, seek appropriate directions in this regard in the writ petitions.

2. Statements have been filed by the State Election Commission in some of the matters taking the stand that the writ petitions are belated in as much as the election has already been announced on 06.11.2020 and they are, therefore, liable to be dismissed on that score. It was also contended in the statements that the petitioners being persons who have not approached this Court at the appropriate time for relief, but approached this Court when similarly placed persons obtained relief, they can be regarded only as fence sitters and

they are therefore not entitled to the relief.

3. Heard the learned counsel for the petitioners as also the learned Standing Counsel for the State Election Commission.

4. The learned counsel for the petitioners in the writ petitions rely on the judgment of this Court in W.P.(C) Nos.21038 of 2020 and 21821 of 2020 to bring home the point raised by them in the writ petitions that reserving a seat successively beyond two occasions, when reserved seats could be distributed in a manner that no seat would go reserved more than twice successively, is against the scheme of Articles 243D and 243T of the Constitution and also the relevant provisions contained in the Kerala Panchayat Raj Act, 1994 and the Kerala Municipality Act, 1994. It was also pointed out that the said writ petitions were disposed of directing the respondents concerned to re-allocate the reserved seats in the said local bodies afresh in a manner that no seat would go reserved more than twice successively. The learned counsel prayed for directions in tune with the judgment in the said cases.

5. The learned Standing Counsel for the Election Commission pointed out, at the outset that most of the writ petitions lack basic pleadings and in substantial number of writ petitions, the impugned orders are not produced. The submission of the learned Standing Counsel, therefore, was that he needs to get instructions in the matters to submit even whether these matters are covered by the judgment of this court in W.P.(C) Nos.21038 and 21821 of 2020. It was, however, contended by the learned Standing Counsel that even if it is found that the writ petitions are covered by the judgment in the said cases, this Court may not interfere with the impugned decisions of the Election Commission, for interference of the impugned decisions would interrupt and protract the election which has already been announced on 06.11.2020. Placing reliance on a table furnished to the Court, the learned Standing Counsel pointed out that the orders impugned in most of the writ petitions were rendered during the last week of September 2020 or latest, by the first week of October 2020, and the petitioners who have not chosen to challenge the impugned orders, have approached this Court



when similar writ petitions instituted at the appropriate time were allowed by this Court. According to the learned Standing Counsel, the petitioners in the writ petitions can be regarded therefore, only as fence sitters and they are not entitled to the relief, especially when granting of relief to them would interrupt and protract the election. It was also pointed out by the learned Standing Counsel that if the writ petitions are allowed, as the nomination for the election needs to be submitted from 12.11.2020, there would be hardly any time to comply with the directions, for allocation of reserved seats afresh involves draw of lots after public notice regarding the time, date and place fixed for draw of lots.

6. In reply to the contentions raised by the learned Standing Counsel for the Election Commission, the learned counsel for the petitioners made elaborate submissions. It was pointed out by them that there was no occasion for the petitioners to know the particulars of the impugned orders to institute the writ petitions then and there, as the allocation of reserved seats was never made known to the public and the petitioners came to know of the decisions

only when the allocation of seats were notified by the concerned local bodies. As such, according to the learned counsel, the writ petitions cannot be said to be belated, especially when they were instituted within two days after the judgments in similar matters were pronounced. It was also pointed out by the learned counsel that insofar as it was found by this Court in the decision relied on by the petitioners that reserving a seat successively for more than two consecutive elections, when reserved seats could be otherwise allocated in a manner that no seat would go reserved for more than two occasions consecutively, is against the scheme of the constitutional provisions relied on in the judgments, it was obligatory for the Election Commission to allocate afresh seats in all the local bodies where such allocation is warranted, even without the aggrieved persons approaching this court. It was also pointed out by the learned counsel that the election process would begin only when a notification is issued in terms of the relevant statutory provisions, and the announcement of the election on which reliance was placed by the Election Commission being only an informal affair, this Court may not

decline relief to the petitioners merely on the ground that election has been announced by the Election Commission. It was further pointed out by the learned counsel that the Election Commission has taken steps to comply with the directions already issued by this Court in two days and therefore, the stand that it would be impossible for them to comply with the directions, if any, issued in these matters, cannot be accepted. It was pointed out that if the writ petitions are not allowed, this is not an issue that the petitioners would be able to agitate in an election petition and their grievance would therefore, go unredressed. It was also pointed out by the learned counsel that the term of the local bodies in the State is due to expire in the coming days and that the Government have to certainly make an alternative arrangement until the newly elected office bearers take charge in terms of the provisions of the statute and therefore, even at the cost of postponing the election for a few days, the direction issued by this court in the individual cases should have been complied with wherever the proposition laid down is applicable, for such compliance is a constitutional requirement. That apart, the

learned counsel for the petitioners also expressed reservations about the announcement of the election made by the Election Commission soon after the pronouncement of the judgment which the petitioners relies on.


7. Should this Court entertain the writ petitions seeking reliefs in respect of the election scheduled to take place from 8.12.2020 is the question to be examined.

8. Before dealing with the question, it must be mentioned that the judgment rendered by this Court, the benefit of which is claimed by the petitioners in this batch of writ petitions, is a judgment in which this Court held that the decision taken by the Election Commission to treat seats reserved for candidates belonging to Scheduled Castes at par with general seats for the purpose of reserving the same again for women, is against the doctrine of equality and also that reserving a seat successively more than twice when reserved seats could be allocated otherwise, is against the scheme of the relevant provisions of the Constitution. In a case of this nature, it was expected would have been prudent for the Election Commission to give effect to the judgment, wherever

allocations were made otherwise than in accordance with the judgment. Instead, it is seen that even when similar writ petitions were pending before this court, the Election Commission chose to announce the election which is already delayed, and started opposing similar writ petitions on technical grounds. I am not examining the question as to whether the Election Commission is justified in adopting the said stand, as it is unnecessary for the purpose of deciding these matters, but I am constrained to make this observation as it is found that it was not impossible for the Election Commission to rectify the flawed procedure adopted by them as pointed out in the judgment as demonstrated by the Election Commission in the matter of complying with the directions in the disposed of cases.

9. The fact that the schedule of the election has been announced on 6.11.2020 is not disputed by anyone. Going by the announced schedule, the first phase of the election is to take place on 08.12.2020, and the nominations of the candidates are to be submitted from 12.11.2020. In other words, there is hardly a month for the election to take place

and only a couple of days for the nominations to be submitted. As rightly pointed out by the learned Standing Counsel for the Election Commission, most of the writ petitions lack basic pleadings and in substantial number of writ petitions, the impugned orders are not produced. The matters, therefore, need to be examined on a case to case basis to ascertain whether they are covered by the impugned judgment. I do not think that the said exercise can be undertaken by this Court before the date fixed for submission of nominations. In other words, if reliefs are granted to the eligible among the petitioners in this batch, the election needs to be postponed. In **A.K.M. Hassan Uzzaman v. Union of India**, (1982) 2 SCC 218, the Apex Court has defined the scope of the jurisdiction of this Court under Article 226 of the Constitution in matters of this nature, and held that if interference in a matter relating to election is likely to interrupt, obstruct or protract the election in any manner, the Court shall not exercise the power under Article 226. The relevant passage of the judgment reads thus:

“Secondly, though the High Court did not lack the jurisdiction to entertain the writ petition and to issue appropriate directions therein, no High Court in the exercise of its powers under Article 226 of the Constitution should pass any orders, interim or otherwise, which has the tendency or effect of postponing an election, which is reasonably imminent and in relation to which its writ jurisdiction is invoked. The imminence of the electoral process is a factor which must guide and govern the passing of orders in the exercise of the High Courts writ jurisdiction. The more imminent such process, the greater ought to be the reluctance of the High Court to do anything, or direct anything to be done, which will postpone that process indefinitely by creating a situation in which, the Government of a State cannot be carried on in accordance with the provisions of the Constitution. India is an oasis of democracy, a fact of contemporary history which demands of the courts the use of wise statesmanship in the exercise of their extraordinary powers 220 under the Constitution. The High Courts must observe a self-imposed limitation on their power to act under Article 226, by refusing to pass orders or give directions which will inevitably result in an indefinite postponement of elections to legislative bodies, which are the very essence of the democratic foundation and functioning of our Constitution. That limitation ought to be observed irrespective of the fact whether the preparation and publication of electoral rolls are a part of the process of ‘election’ within the meaning of Article 329(b) of the Constitution. We will pronounce upon that question later in our judgment.”

The proposition aforesaid has been reiterated by the Apex Court in **Election Commission of India v. Ashok Kumar**, (2000)8 SCC 216, and held further that the Court shall interfere

in matters relating to election only if it subserves the progress of the election and facilitates the completion of the election. True, the election process has not formally commenced inasmuch as the notification is yet to be published. But in so far as the election has already been announced and since it is found that this Court may not be in a position to complete the adjudication in these matters before the date for filing of the nominations, having regard to the spirit of the judgments of the Apex Court aforesaid, I am of the view that I should refrain from exercising my jurisdiction under Article 226 of the Constitution in these matters. I take this view also for the reason that the term of the local bodies in the State is due to expire on 11.11.2020 and the mandate of Articles 243E and 243U of the Constitution is that the election to constitute new local bodies is to be conducted before the expiry of the term of the earlier local bodies.

In the circumstances, the writ petitions are dismissed.
