		The aforesaid news report goes to state that the pollutants
		which is being emitted/discharged from M/s. Bhatia Wine
		Merchants Pvt. Ltd. situated at village Mohbhatta-Dhooma, District
		Mungeli, is causing menace to the environment and surroundings.
		The entire population of about 20,000 people is being affected by
		the industrial activities of M/s. Bhatia Wines. The report further
		goes to state that though there is provision under the various
		Environmental Acts to discharge the sub-standard quality of spirit



but only after its treatment which is being violated by the said industry. Because of the poisonous effluents, paddy of more than 350 acres have been affected. Foul smell from those effluents have made the life of the people of the surroundings miserable which is causing difficulty in breathing, itching, burning sensation in the eyes, especially to the children and old aged persons. The police has also taken sample of water from the spot.

 The aforesaid news report portrays a very alarming and terrifying situation as lacs of fishes have died because of the effluents being released in the culvert adjacent to the factory which further merges with Shivnath river making the river polluted.

Heard Mr. Prafull N. Bharat, Advocate General along with Mr. Shashank Thakur, Deputy Advocate General for the State/respondents, Mr. Amrito Das, learned counsel for the Chhattisgarh Environment Conservation Board, Mr. Abhishek Sinha, learned Senior Advocate along with Mr. Aditya Pandey, learned counsel for M/s. Bhatia Wine Merchants Pvt. Ltd.

Learned Advocate General submits that on 27.04.2024, the Sub Divisional Magistrate, Pathariya, District Mungeli, has directed the the Regional Manager, Environment Conservation Board, Bilaspur Pollution Control Board for getting an inquiry done with



respect to the death of fishes on account of releasing untreated water containing hazardous chemicals from the factory which has been causing number of health hazards directly affecting the people, animals, plants and crops and to submit the report on 02.05.2024. A copy of the said memo was sent to the Collector, Mungeli, Nayab Tahsildar and Executive Magistrate also. On the said date itself, a show cause notice was also issued to M/s. Bhatia Wine Merchants Pvt. Ltd. with regard to discharging of chemical containing water in the river and sought explanation till 02.05.2024. Mr. Bharat submits that thereafter, a reminder letter was also sent on 12.07.2024 to the Regional Manager. Environment

High Cour of Chhatt sgarh Mr. Bharat submits that thereatter, a reminder letter was also sent on 12.07.2024 to the Regional Manager, Environment Conservation Board, Bilaspur informing him to conduct an inspection and submit its report with his clear opinion on 23.07.2024, however, the same has not been received till date. On the same day, another memo was sent to Mr. B.S.Bhatia, M/s. Bhatia Wine Merchants Pvt. Ltd. Dhuma, Sargaon, informing him about the aforesaid situation and to submit his response on 23.07.2024.

Mr. Amrito Das, learned counsel appearing for the Environment Conservation Board states that he may be granted some time to verify as to what action has been taken on the

communication made by the State the Environment to Conservation Board. He has also produced a letter dated 20.07.2024 issued to M/s. Bhatia Wine Merchants Pvt. Ltd. with respect to the discharging of industrial waste through water through underground plastic pipe to Khajri Nala which ends up flowing into the Shivnath river. Vide the said letter, as a preventive measure, the industry has been directed to close its operation until the water analysis report from the concerned departments and report of the Committee constituted by the Head Office is obtained and the action taken thereafter. M/s. Bhatia Wine Merchants Pvt. Ltd. has further been warned that environmental compensation may also be imposed upon it.

Mr. Abhishek Sinha, learned Senior Advocate appearing on behalf of M/s. Bhatia Wine Merchants Pvt. Ltd. submits that so far as the letter dated 20.07.2024 issued by the Environment Conservation Board is concerned, he is unable to state anything whether the same has been received by M/s. Bhatia Wine Merchants Pvt. Ltd. or not. He states that the Company - M/s. Bhatia Wine Merchants Pvt. Ltd. is ready to get an inquiry done with respect to the allegations levelled against it in the aforesaid news report as well as by the Sub Divisional Magistrate, Pathariya



and the Environment Conservation Board, Bilaspur.

Let this matter be listed on 30th of July, 2024.

Office is directed to implead M/s. Bhatia Wine Merchant Pvt. Ltd. as party respondent No. 8 in this petition.

The copy of the documents supplied by the learned counsel for the State as well as Environment Conservation Board, are taken on record.

On the next date, Mr. Amrito Das, learned counsel appearing for the Environment Conservation Board shall inform this Court as to what action the Board has taken after issuance of memo dated 27.04.2024 by the Sub Divisional Magistrate, Pathariya, as well as Mr. Sinha shall also inform this Court as to whether it has received the notice dated 20.07.2024 issued by the Chhattisgarh Environment Conservation Board, Bilaspur and whether they have submitted any response to the same or not.
