The Chief Secretary of the State is directed to file his personal affidavit showing the current status of the construction work at Dhaneli-Mandir Hasaud Raod as well as Mopka-Sendri bypass as the learned Advocate General states that the tender in question was already issued and work is still in progress, but what is status of the work, he should file his personal affidavit with documentary evidence.

Mr. Sandeep Dubey, learned counsel, appearing for respondent Nos. 7 & 8 / Municipal Corporation, Bilaspur in WPPIL No. 127/2021 states that an affidavit has been filed by the Municipal Commissioner. The relevant portion of the same is reproduced hereinunder:-

It is respectfully submitted on behalf of deponent that, the Municipal Corporation continuously working on various field which relates to the needs of General Public likewise drainage, street lights, cleanings, maintenance as well as construction of new roads, repairing of roads, after direction of the Hon'ble Court, the Municipal Corporation repairs the following roads:-

A copy of the list along with certificate issued by the Executive Engineer, in which the repairing of the roads are completed are collectively annexed herewith as **ANNEXURE-D/1**.

5. That, the Municipal Corporation issued various tenders for the construction of the C.C.Roads under the limits of Municipal Corporation, in which the Contract has been awarded to the contractor and they are started the works, which would be complete as per the norms of the contract agreement. The

construction of the some of the roads under process of tenders, which would be finalize as per the norms prescribed under the PWD manual."

Ms. Ruchi Nagar, learned counsel, appearing for the intervenor states that with respect to Shubham Vihar the roads have not been repaired.

In view of the same Shri Dubey has stated that the said grievance of the intervenor would be taken into consideration.

Meanwhile the Amicus Curiae are also directed to verify the affidavit given by the Municipal Commissioner regarding the repairing work and construction of new roads and its maintenance enlisted in paragraph 4 of the said affidavit.

In compliance of the Court's order dated 03.10.2024, an affidavit has been filed on behalf of respondent No.4 / NHAI on 17.11.2024, relevant portion of the said affidavit reads as under :-

"That in compliance of the Hon'ble Court order dated 03.10.2024, the office of

answering respondent made correspondence with the concerned concessionaire who is engaged in the construction of subject matter NH Project, through answering respondent. The concessionaire vide its letter dated 16.11.2024 submitted the progress report of Service Road between Km. 23.180 to Km 24.854 (RHS) in Bilaspur-Pathrapali section of NH-130. That the answering respondent is report the filing progress and other documents of the concerned aforementioned project before this Hon'ble Court, copy of which is filed herewith as ANNEXURE A. It is humbly prayed that the progress report may be taken on record, in the interest of justice."

Mr. Prateek Sharma, learned Amicus Curiae states that he has also prepared a report and it is stated that he will file the same before the Registry of this Court today only after serving copy of the same to learned counsel, appearing for the State, NHAI and other stakeholders so that discrepancies which have been pointed out in the said report be rectified.

Fresh affidavits shall be filed by the respective respondents to that report also.

The Regional Officer of NHAI, Raipur is directed to file his personal affidavit in the matter with respect to the report submitted.

List these matters on 10.12.2024 for monitoring further progress in the matter.
