	The aforesaid news report goes to state that the officers of
	the Public Health Engineering Department of the State have
	played fraud and have obtained certificate claiming 100%
	completion of water supply in all the houses of various villages
	when the fact is that water supply is being made to very few
	houses.

Order Sheet

Looking to the seriousness of the matter and further it involves concern of the public at large relating to supply of water to the households located in various villages, this matter is taken up for hearing during the winter holidays.

The news report also goes to state that in one of the village namely Daihanpara, water is being supplied only to 130 houses which is merely 20% of the population of that village. After initiation of the Jal Jeevan Mission, Bilaspur has remained the most disputed District. It further goes to state that in village Panchayat, Bannakdih, those who do not have ration cards are not being given water supply connection. In various villages, the officials have claimed that have completed the work of installing taps in all the houses when the fact of the matter is that even pipelines have also not been laid till date in the entire village.

Alongwith the news report, the pictures of under constructed overhead water tank has also been published which speaks volumes as without construction of the overhead water tank, water cannot be supplied to all the houses located in the villages. Despite the widespread irregularities, the current Chief Engineer has claimed that an investigation will be conducted. The villagers are unhappy with the Sarpanch and Panchayat members, who seem to be doing nothing to address the issue. Furthermore, there is a discrepancy in the water bills, with some areas being charged ₹100 and others ₹80.

Mr. Raj Kumar Gupta, learned Additional Advocate General submits that the aforesaid news report is not correct and some erroneous facts have been tried to be portrayed as till date, only three villages, namely Newra, Bhawakapa and Bannakdih, have been certified to have completed 100% of the work of water supply to the houses whereas the news report states about eight villages.

In view of the above submission, we deem it appropriate to direct the respondent No. 2, Secretary, Public Health & Engineering Department, Government of Chhattisgarh, to file his personal affidavit addressing the issues involved in the aforesaid news report in detail. He shall inform this Court through his affidavit as to when the Jal Jivan Mission was launched in the State and by what time, the same would be completed.

Let the matter be listed again on 8th of January, 2025.
