26/12/2024	<p>The present Public Interest Litigation has been taken <i>suo moto</i> cognizance by this Court regarding news item namely “सेना की जमीन से चोरी की गई मुरूम की मोटी परत बिछ रही कॉलोनियों में” “रायपुर रोड में 300 एकड़ में बन रही कॉलोनी, 60 एकड़ में मुरूम से बनाई सड़क” published in the Daily News Paper Dainik Bhaskar, Bilaspur Bhaskar, dated 24 December, 2024.</p> <p>It has also come to the notice of this Court that similar news items have also been published in the Daily News Paper Danik Bhaskar, Bilaspur on 13.12.2024, 14.12.2024, 17.12.2024 and 20.12.2024.</p> <p>Looking to the seriousness of the matter where <i>muroom</i> has been excavated from the land belonging to the Army, this matter is being taken up for hearing during the winter holidays.</p> <p>Through the news item published on 24.12.2024, it has been highlighted that at Raipur road near</p>

Parsada, Divine Group through its proprietor Shri Pawan Agrawal, Seven Hills, Near Jain Mandir, Vinoba Nagar, Bilaspur (C.G.) Pin 4959001, is constructing a colony namely 'Fortune Element Colony', wherein the builder is building roads in the colony by buying stolen *muroom* at a throwaway price and at present concrete is being done on a road at about one kilometer to enter the colony from the main gate. A thick layer of stolen *muroom* has been laid beneath it and it is alleged that the said stolen *muroom* has been extracted from army land in village Telsara near Chakarbhatha Airport.

Mr. R. K. Gupta, learned Additional Advocate General, appearing for the State / respondent No.2 to 9 has produced a copy of the letter dated 25.12.2024 sent by the Mining Officer, District Bilaspur (C.G.) to M/s. Fortune Element, Prop. Shri Pawan Agrawal, District – Bilaspur (C.G.), who is a private builder, against whom allegation has been made that he is being using the *muroom* extracted from the land of the Army for the use of developing his colonies.

In view of the same, Registry is directed to

implead 'Fortune Element Colony' through its proprietor Shri Pawan Agrawal, Seven Hills, Near Jain Mandir, Vinoba Nagar, Bilaspur (C.G.) Pin 4959001 as respondent No.10 in the present WPPIL.

Learned Additional Advocate General has stated that notice has already been issued to Shri Pawan Agrawal in this regard and his reply is still awaited.

Mr. Ramakant Mishra, learned Deputy Solicitor General, appearing through video conferencing for Union of India / respondent No.1, as per instruction, has stated that Defence Estate Officer has also made request to the Collector, Bilaspur to stop the excavation of *muroom* from the land of Army.

Respondent No.1 as well as respondent No.3 are directed to file their respective personal affidavits in this regard.

The learned Additional Advocate General shall ensure that notice about the present PIL is also served on the newly added respondent No.10, 'Fortune Element Colony' through its proprietor Shri Pawan Agrawal, Seven Hills, Near Jain Mandir, Vinoba Nagar,

Bilaspur (C.G.) Pin 4959001, who may appear in person or through his counsel, if he so wishes, before this Court on the next date of hearing.

Let the matter be listed again on 9<sup>th</sup> of January, 2025.
