

<u>ORDER</u>

The present transfer petition has been filed by the petitioner(Daughter-in-law of the sole respondent) seeking transfer of the case bearing MC No. 825 of 2023 filed by the respondent(Mother-inlaw) under the provisions of the Protection of Women from Domestic Violence Act, 2005(for short, 'the D.V. Act'), titled as *"Neelam Berry Vs. Alisha Berry"*(subject-case), pending in the Court of Metropolitan Magistrate, Mahila Court-05, West, Tis Hazari Courts, Delhi to the Court of Chief Judicial Magistrate, Ludhiana, Punjab.

impairment. She is unemployed and is fully dependent on her father for her survival. It is further pointed out that the Court below has issued bailable warrants against the petitioner vide order dated 06.02.2024.

This Court is constrained to observe that there is no justification whatsoever for the Trial Court to have issued bailable warrants in an application filed under the provisions of the D.V. Act. The proceedings under the D.V. Act are quasi criminal proceedings which do not have any penal consequence except where there is a violation or breach of a protection order. Therefore, the learned Magistrate was absolutely unjustified in directing issuance of bailable warrants against the petitioner.

Having considered the submissions advanced by learned counsel for the petitioner and after going through the material available on record and considering the fact that the proceedings of the by the husband of divorce petition filed the petitioner have already been transferred by this Court from Family Court, West, Tis Hazari, New Delhi to Family Court, Ludhiana District Court, Punjab vide order dated 14.08.2024 passed in Transfer Petition(Civil) No. 1506 of 2024, the instant transfer petition stands allowed in the

The Court where proceedings are pending shall transfer the records to the transferee Court promptly and without any delay.
