## Hon'ble Saurabh Srivastava, J.

- 1. Heard Sri Rajat Aren, learned counsel for petitioners and Sri Atul Kumar Kushwaha, learned counsel who preferred his Vakalatnama today on behalf of respondent no.2 as well as learned AGA.
- 2. In spite of orders dated 14.02.2025 and 04.03.2025 through which specific orders have been passed in favour of Commissioner of Police, Commissionerate Lucknow for ensuring personal appearance of respondent no.2 i.e. Jyoti Saxena w/o Prashant Saxena, daughter of Krishan Murari Saxena before this Court but the said orders have not been complied with till today.
- 3. Order dated 14.02.2025 has been taken up by the concerned police authorities only for ensuring service of notice and the same has been reported by the concerned police station to Deputy Commissioner (East), Commissionerate Lucknow which is available on record.
- 4. By bare perusal of the report submitted by Commissioner of Police, Commissionerate Lucknow, it is crystal clear that the compliance report has been submitted before learned Chief Judicial Magistrate, Lucknow without going through the order dated 14.02.2025 wherein it is specifically mentioned under paragraph-1 that "Police Commissioner, Lucknow Commissionerate is directed to ensure personal appearance of respondent no.2, i.e. Jyoti Saxena, wife of Prashant Saxena, D/o Krishan on the next date."
- 5. Either of the authorities of police department which includes Commissioner of Police, Deputy Commissioner of Police (East) and SHO, Police Station Chinhat alongwith Sub-Inspector, Police Station Chinhat, District Lucknow took no pain in shape of at least going through the orders passed by this Court on dated 14.02.2025 and 04.03.2025.

- 6. Director General of Police, U.P. is hereby directed to initiate a proper inquiry against Commissioner of Police, Commissionerate Lucknow, Deputy Commissioner of Police (East), Commissionerate Lucknow and SHO, Police Station Chinhat alongwith Sub-Inspector Mohit Kumar, Police Station Chinhat who submitted report on dated 07.03.2025 without going through the order dated 14.02.2025.
- 7. Intimation and outcome of the said inquiry be placed before Registrar (Compliance) of this Court.
- 7. Upon service of notice which has been ensured in pursuance of order dated 14.02.2025, Sri Atul Kumar Kushwaha, learned counsel is appearing on behalf of respondent no.2 who assured that on the next date, respondent no.2 will be present in person before this Court.
- 8. Put up this case on **25.03.2025** as fresh.
- 9. Interim order dated 14.02.2025 is extended till the next date of listing.
