- **1.** Heard.
- **2.** The petitioners have approached this court seeking issuance of a writ in the nature of certiorari for quashing of the First Information Report dated 30.01.2025 bearing Case Crime/ FIR No.40 of 2025 under Sections 64, 74, 115(2), 316(2), 324(4), 333, 351(3), 352 of the BNS, 2023 and Section 66D of IT Act, 2008, Police Station Vibhuti Khand, District Lucknow and with further prayer to not arrest or take coercive steps or set up an enquiry against the petitioners.
- 3. Learned counsel for the petitioners submits that informant/victim namely Pooja Rawat is regularly filing false complaints/FIRs and has lodged as many as 11 of them against large number of persons and now the 12th one is against the petitioners, the details of 11 other FIRs are given in paragraph 22 of the writ petition. It is also claimed that all the complaints lodged by the informant/victim Pooja Rawat are through same lawyer namely Shri Parmanand Gupta. The details of complaints/FIRs other than the present impugned FIR are as follows:-

- **4.** It is also apparent that the informant and her counsel are in collusion with each other and have lodged false FIRs against large number of people for serious offence only to extract money from them. The present FIR is also such an FIR lodged to create pressure.
- **5.** On instructions learned AGA states that such complaint cases were being lodged under difference offence and the present FIR thereafter is also in continuation with the same. - **6.** Considering the seriousness of the allegations with regard to

the lodging of large number of criminal complaints by the

victim/ informant Pooja Rawat through her counsel Shri

Parmanand Gupta against large number of persons, of similar

nature, we feel it appropriate to direct the CBI to enquire into

the matter and submit its report.

7. The CBI shall submit its report to this Court by 10.04.2025.

10. In view of the above, until further orders, it is provided that
