HIGH COURT OF JUDICATURE AT ALLAHABAD

NOTICE

To pay tribute to, and in the memory of, those who lost their lives on account of the act of terrorism in Pahalgam in the Union Territory of Jammu & Kashmir and a notice in this regard may be issued by the Learned Registrar General:

- a). A silence of two minutes' be observed at 10:30 AM on 25th April, 2025 at the High Court of Judicature at Allahabad and its Bench at Lucknow.
- b). To indicate the commencement of two minutes' silence, siren will be sounded from 10.29 AM till 10.30 AM at Allahabad and its Bench at Lucknow.
- c). At the appointed time, the Hon'ble Judges, lawyers, members of the officers & staff and all other persons present in the Court and in the Registry will stand up and will observe two minutes' silence.
- d). After the two minutes' silence is over "all clear siren" will again be sounded from 10.32 AM till 10.33 AM at Allahabad and its Bench at Lucknow.


