The Court made the following:

ORDER:

Heard Sri J.V.Phaniduth, learned counsel for the petitioner.

- 2. The petitioner is the 2nd plaintiff in O.S. No.103 of 2012 on the file of the Court of the XIII Additional District & Sessions Judge, Vijayawada, instituted for cancellation of the agreement of sale as well as the acceptance deed dated 30.10.2008.
- 3. The suit was filed against defendant Nos.1 to 66. In the said suit, the petitioner/plaintiff filed a memo seeking withdrawal of the suit against defendant Nos.6 to 66, contending that they are not necessary parties to the suit for specific performance of contract.
- 4. The learned trial Court, by order dated 10.04.2025, rejected the said memo on the ground that no judicial order can be passed on a memo.
- 5. Aggrieved by the rejection order dated 10.04.2025, the petitioner has filed the present Civil Revision Petition under Article 227 of the Constitution of India.
- 6. Learned counsel for the petitioner submits that the petitioner merely seeks to withdraw the suit against defendant Nos.6 to 66, who are not necessary parties to the adjudication of the relief of specific performance. He submits that since the relief sought was only for withdrawal of the suit against defendant Nos.6 to 66 for the aforesaid

reasons, the provisions of Order XXIII Rule 1 of Code of Civil Procedure Code, 1908 (for short, "CPC"). would not be applicable.

- 7. I have considered the aforesaid submissions and perused the material on record.
- 8. It is not merely the nature of the prayer that is material, but also the manner in which such relief is sought. Withdrawal of a suit, whether in whole or in part, is a substantive act governed by specific procedural requirements under the CPC. Therefore, such relief must be sought by filing an application in accordance with the procedure prescribed in CPC. It is settled in law that CPC is a complete code. The applicant has to follow the legal provisions and the procedure prescribed for any prayer in the pending suit.
- 9. The prayer has been made in the memo on the ground that defendant Nos.6 to 66 are not necessary parties. For seeking such relief, and for deletion of their names from the array of parties, Order 1 Rule 10 CPC may be the appropriate provision. The appropriate course of action was by filing an application in accordance with the procedure prescribed under CPC.
- 10. Learned counsel for the petitioner has not been able to point out any provision of law under which a memo could be filed for the purpose

it was filed. Once remedy is prescribed by the CPC, the same has to be

availed in the manner prescribed.

11. I do not find any illegality or infirmity in the order passed by the

learned trial Court, warranting interference by this Court.

12. The Civil Revision Petition lacks merit and is, dismissed.

No order as to costs.

As a sequel thereto, miscellaneous petitions, if any pending,

shall also stand closed.
