- 2. The instant writ petition, purportedly in public interest, has been filed *inter alia* seeking a direction to the Bar Council of India and Bar Council of Uttar Pradesh to reserve some of the positions in the Bar Council and Bar Associations for persons with disabilities, who are practicing as advocates.

 - 4. At this stage, it seems difficult for this Court to interfere

and issue a positive mandamus for providing the reservation that is sought. However, the reservation for persons with disability essentially being a policy matter, we dispose of this writ petition with a direction to the Bar Council of India to consider the cause espoused by the petitioner in light of the relevant legislative policies and statutes emanating from the constitutional principles of equality.

- 5. Consequently, at this stage, we leave it open to all the stakeholders to take an appropriate decision in the subject-matter. Needless to say, the petitioner shall not be precluded from approaching the appropriate forum, if so required, at a later stage.
- 6. All pending applications, if any, also stand disposed of.
